

MINUTES PARKER CITY COUNCIL
Parker Senior Center

June 14, 2018

Mayor Wayne Burk called the meeting to order at 7:01 p.m.

PLEDGE AND PRAYER: The pledge was given and Kathy Harrison offered the prayer.

ROLL CALL: Cherry Buckley, City Clerk, took the Roll. All council members were present.

PUBLIC COMMENTS: None

APPROVAL OF MINUTES: The Mayor asked if council had read the Minutes from the May 10th meeting and the June 5th special meeting and if there were any additions or corrections.

Lance Burroughs moved to approve the Minutes from May 10th, 2018 meeting and June 5th special meeting as read. Jerry Summers seconded the motion and it carried 5-0.

OLD BUSINESS:

Copier for City Hall: Bill Bigaloe from Modern Copy Systems made a presentation to council regarding Kyocera copiers. He discussed three options; two were similar in that they were back and white printer, copier, and fax with color scanner and only differed in paper tray capacity and toner yield and the third was a color printer, copier, scanner. Mr. Bigaloe stated that the city would be eligible for the municipal discount as well.

There was some discussion about the life of the machine and Mr. Bigaloe said most of his clients have had their copiers for years. He also stated he could install the copier next week.

Clerk Buckley stated she would really like to have a color printer so that she could put out color flyers and print city letterhead in color.

Lance Burroughs moved to purchase Option #3 Kyocera color printer, copier, and scanner at \$1,650.00. Ryan Sobba seconded the motion and it carried 5-0.

Street Update: Mayor Burk announced that all the streets in Parker now have a hard surface. He said there are still a few blocks that need chip seal; N. Western, part of South St., Taft, Catalpa and Short Streets. The Mayor stated he anticipates this will be completed by the county sometime this summer.

NEW BUSINESS:

Santa Comes to Parker Donation: Mayor Burk stated the city generally donates money for the Christmas celebration at this time of year. He said we usually give the Orth's \$700 to help purchase meat to be given away.

Ryan Sobba moved to donate \$700 the Santa Comes to Parker. Lance Burroughs seconded the motion and it carried 5-0.

It was discussed that the City normally donates money to Crystal Riggs to help purchase gifts for the children at Santa Comes to Parker. The Clerk was asked to contact Ms. Riggs to see if she was still gathering items for the children.

Mosquito Spray: The Mayor reported the City was going to spray for mosquitos before the music festival on the 23rd of June. He went on to say it was necessary to purchase the spray and cleaner. He said the City used 20 gallons of spray and 2 gallons of cleaner last year. Mayor Burk also mentioned the sprayer was currently putting out too much spray and that he had contacted someone to look at it to see if it could be repaired. He reminded council the sprayer was given to us for free from the City of LaCygne and also that parts were no longer available for it.

Ryan Sobba moved the City purchase 20 gallons of mosquito spray and 2 gallons of cleaner if the sprayer could be fixed. Jody Bloodgood seconded the motion and it carried 5-0.

Cold Patch: Mayor Burk stated it was planned to repair some turn-outs in the City and he estimated it would take about 10 ton of cold patch to do the job. He went on to say the cost would be approximately \$60 per ton with an additional \$100 for freight.

Ryan Sobba moved to purchase 10 ton of cold patch at a cost of \$700 including freight. Lance Burroughs seconded the motion and it carried 5-0.

OTHER BUSINESS: Ryan Sobba asked if we had any news from Don George about acquiring a fish feeder. He said if Mr. George can't find us a used one then he would like to revisit purchasing a new one.

Clerk Buckley was asked to contact Mr. George and to put the purchase of a fish feeder on next month's agenda.

DEPARTMENT REPORTS

City Attorney, Gary Thompson, was not present.

City Treasurer, Kathy Harrison, gave the Treasurer's Report and explained the transfer of the "windfall" money we received from Linn County (\$13,278.00) which was put into the General Fund by error into the Street Fund as originally planned.

Ryan Sobba moved to pay the June bills. Lance Burroughs seconded the motion and it carried 5-0.

Ms. Harrison reported she has a meeting with the county to go over the 2019 Budget on June 19th.

Mayor Burk stated he would like to transfer \$15,000 out of the Sewer Fund to be put into a Capital Outlay Fund.

Ryan Sobba moved to transfer \$15,000 out of the Sewer Fund to be put into a Capital Outlay Fund. Lance Burroughs seconded the motion and it carried 5-0.

City Clerk, Cherry Buckley, read a thank-you note from Dayton Snyder, one of the scholarship recipients of the joint City of Parker/Heritage Park Board Scholarship.

Police Chief, Leroy McConico, was not present and Mayor Burk reported that he had resigned two days after the last meeting.

Maintenance, Chad Page, had nothing new to report.

Water and Sewer Contractor, Chad Page, had nothing new to report.

Compactor Operator, Myrtle Douglas had nothing new to report.

Mayor Burk added the county said the small amount material left over from the Citywide Clean-up could be put into the trash compactor.

Board Representatives:

PWWSD#13 - Representative Chad Page said there is not much going on right now.

Park Board - Mayor Burk had nothing to report beyond the music festival On June 23rd.
